Please verify immediately with your travel agent or the Czech Republic Embassy or Consulate in your country if a visa is required for your travel to the Czech Republic. The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before 09 th February , 2017 to the Czech Gymnastics Federation.
The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.
The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.
The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.
The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.
The LOC will subsequently offer insurance at the Federations own charge. Information about the cost of the insurance will be given with the Work plan.
The invited participating federations must pay for the travel costs of their delegation members.
The Travel Schedule Form must be returned to the LOC by 09 th February 2017. If person from one delegation/Federations are arriving and departing with different flights, please fill in separate travel forms for each group of persons and indicate on the travel form the exact number of persons.
The LOC may provide transportation to all delegation members, who have booked their accommodation through the LOC, from the Prague Airport, Vienna Airport, Bratislava Airport or Brno Airport to the their hotel and back on the official arrival and departure days.
