<b>JUDGES AND JURIES</b>	<p><b>All judges must have a current valid category for the respective discipline (aerobic gymnastics).</b></p> <p>Every Nation should register at least one judge with a valid FIG Brevet for the current cycle.</p> <p><b>Failure to do so may result in a fine of 700 Euro to be paid to the LOC in order that the LOC invites neutral judge/s. The fine for missing a judge should be paid to the LOC no later than 31<sup>st</sup> of July 2024.</b></p> <p>The number of Judge's panels will be decided depending on the number of participating competitors and judges.</p> <p>The Juries will be set by a draw from the judges present at the event. The priority will be given to the judges of the highest category.</p>

<b>EVENT FORMAT</b>	<p>The competition consists of Qualifications and Finals in Seniors and Juniors in all 6 categories. In case that there are less than 9 participants per category in the Qualifications, no Qualification is necessary. In such cases the LOC will make a decision based on the total number of entries.</p> <p><b>QUALIFICATIONS</b></p> <p>The participation in Qualifications is limited to <b>the units mentioned in the paragraph "Size of delegation"</b> except for the Organizing Federation. There is no limitation to the number of units for the Organizing Federation.</p> <p><b>FINALS</b></p> <p>The top 8 (eight) competitors from the Qualifications in Seniors and Juniors in each category (IW, IM, MP, TR, GR, AD) will take part in the Finals (maximum two per Category and Nation).</p> <p>In addition, if the organizing Federation has not qualified competitors in any category in Seniors and in Juniors, it may nominate one participation in max.1 category in each - Senior and Junior of its choice.</p>

The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before <b>26<sup>th</sup> of June 2024</b> to the e-mail of the OC – <a href="mailto:aerobicub@gmail.com">aerobicub@gmail.com</a></p> <p>The request must be made using the official form and include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city where the visa application support letter must be sent to.</p>
<b>INSURANCE</b>	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness (including COVID-19), repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation.</p> <p>Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. Based on the request the LOC will provide information about the cost.</p>
<b>SAFEGUARDING</b>	<p>From the official event day of arrival until the official day of departure, participants (gymnasts, coaches, judges and any other delegation members) have the possibility to contact by phone or e-mail the LOC Safeguarding Officer in case of harassment and abuse of any type or if they are worried and do not feel comfortable.</p> <p>The information regarding the LOC Safeguarding Officer will be communicated upon arrival of the delegations on site.</p> <p>In addition, posters of the "10 Golden Rules of Gymnastics", the FIG campaign to raise awareness about youth protection in Gymnastics, will have to be displayed in several locations, including training and warm-up halls and public zones.</p>

<b>LOCAL TRANSPORTATION</b>	<p><b>Arrival and departure – Sofia or Plovdiv:</b> The LOC may provide transportation to all delegation members, <b>who have booked their accommodation through the LOC</b>, from and to Sofia or Plovdiv airport, railway station or central bus station to the official hotel in Plovdiv and back on the official arrival (<b>29<sup>th</sup> of August 2024</b>) and departure days (<b>2<sup>nd</sup> of September 2024</b>). An International event for:  
 - AG – for the categories IW/ IM/ MP/ TR/ GR/ AD and  
 - ND for the categories IW/ IM/ MP/ TR/ GR will also be held (not sanctioned).  
 For those age groups an exception in the age is possible only for TR and GR categories as follows:  
 - TR category – max one of the gymnasts could be from a lower age group –  
 In AG 12-14 (born 2013 - 2015) and in ND 9-11 (born 2016 - 2017)  
 - GR category – max two of the gymnasts could be from a lower age group –  
 In AG 12-14 (born 2013 - 2015) and in ND 9-11 (born 2016 - 2017)  
 Conditions, number of units, deadlines and prices are the same as for the Seniors and Juniors. No FIG license is requested.

The Draw for the starting order for Qualifications and Finals will be done in advance by the Technical Committee of Aerobic Union Bulgaria based on the Definitive entries and will be distributed to all Nations.

More information will be given with the Work Plan which will be distributed to all registered federations not later than 19<sup>th</sup> of August 2024.
