<b>ENTRY FEES</b>	<p>No entry fee will be applied for this event for all delegation members who booked their accommodation through the LOC.  Otherwise apply: 100,- EUR per gymnasts.  At the time of the Definitive entry (2 months prior to the event) 100% of the entry fee must be paid to the LOC.  The entry fee is not refundable. Entries without payment of the entry fees will be considered as invalid and will be refused.  The LOC will waive the costs for the entry fees for the top three gymnasts per apparatus listed in the World Ranking List.</p>						
<b>ACCREDITATION</b>	<p>Accreditations will be given at the "Arena Savaria" at the arrival of the Delegations.  In addition, the LOC will distribute information regarding the safeguarding Officer operations plan upon accreditation.</p>						
<b>COMPETITION FORMAT</b>	<p>The World Challenge Cup competitions consist of the following:</p> <ul style="list-style-type: none"> <li>• Qualifications and Apparatus Finals</li> <li>• Gymnasts can only compete on the apparatus they register for</li> <li>• In case of a tie at any place, the tie-breaking rules as set up in the Technical Regulations, Section 2 shall be applied.</li> </ul> <p><u>Qualifications:</u></p> <ul style="list-style-type: none"> <li>▪ Participation is limited to 2 gymnasts per NF on each apparatus.</li> <li>▪ In addition, the Organizing Member Federation is allowed to name a max. of 4 "hors concours" competitors (from the Organizing Member Federation) in Women's Artistic Gymnastics and a max. of 4 "hors concours" competitors (from the Organizing Member Federation) in Men's Artistic Gymnastics for a total of 8 "hors concours" gymnasts (i.e. while one "hors concours" gymnast can compete on more than one apparatus, not more than one "hors concours" gymnast can compete on an apparatus). They must be named at the time of the closing of the nominative registration and they cannot qualify for the Finals. <b>DRAWING OF LOTS</b>	<p>The gymnasts' drawing of lots for all FIG World Challenge Cup events will be managed electronically.</p> <p>If not possible, it will take place on site, during the orientation meeting or during a separate function organized for that purpose with invitation to all participating NFs. All delegations upon arrival/accreditation must submit a confirmation of starting order forms, a final validation of the delegation’s apparatus and starting order.</p> <p>The Technical Delegates may apply adjustments to the starting order should the Draw generate organizational problems at the time of the competition.</p> <p>At the time of the nominative registration, the apparatus on which the gymnast will compete must be mentioned. <b>Until accreditation</b>, Gymnasts may be changed and apparatus can be added, as long as 2 gymnasts per apparatus per federation is respected</p>

<b>ANTI-DOPING</b>	<p><b><u>Doping controls</u></b> Doping controls will be organised by the International Testing Agency (ITA) on behalf of the FIG and according to the World Anti-Doping Code (WADC), the international standards enacted by the World Anti-doping Agency (WADA) and FIG Anti-Doping Rules.</p> <p><b><u>Host federation WADC compliance</u></b> The exploitation of any rights related to the hosting of an event is subject, at all times, to the compliance with the WADC and the international standards enacted by WADA. Regardless of whether the event has already been allocated or not, the FIG may terminate any collaboration with the host federation or the LOC, immediately and without paying any penalty and/or compensation or incurring liability of any kind, under the following circumstances:  <ul style="list-style-type: none"> <li>(i) if the National Anti-Doping Organisation (NADO) in charge in the concerned country is declared non-compliant by WADA</li> <li>(ii) if the relevant country has been ruled ineligible to host the event.</li> </ul> In such cases, the FIG is entitled to reassign the event to any other host federation in another country where the WADC and the WADA international standards are fully respected.</p>
<b>VISA</b>	<p>Please verify immediately with your travel agent or the Embassy or Consulate in your country if a visa is required for your travel to Hungary. The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before 26<sup>th</sup> July 2025 to the LOC.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>

In case a gymnast received a DNS/DNF during the Apparatus Finals, points will be awarded based on the Qualifications ranks. If after application of the tie breaking rules outlined in the Technical Regulations, Section 2, there is still a tie, the points of the equal ranks will be added and divided by the number of ties.

In case that less than four federations participating per apparatus, no World Challenge Cup points will be given.

Based on the World Challenge Cup points assigned, separate men's and women's World Challenge Cup Ranking Lists are established on each apparatus as follow:

These Ranking Lists are established after the first World Challenge Cup event of the year and end with the last World Challenge Cup event of the year.

**WINNER OF THE ANNUAL WORLD CHALLENGE CUP SERIES**

The winner of the annual World Challenge Cup Series is the gymnast with the highest number of points on the respective apparatus after the last event of the year, taking into consideration the best results (maximum 3), regardless of the number of competitions the athletes participated in.

Should there be a tie after the last competition, it will be broken as follows:

- a. The ranks of the max. three (3) counting exercises will be added and the gymnast with the lowest total prevails.  
Note: in case of a tie in the ranks to determine the three counting exercises, the exercises with the highest final scores will prevail.
- b. If the tie remains, the final scores of the max. three (3) counting exercises will be averaged and the gymnast with the highest average prevails.
- c. If the tie remains, the total E-scores of the max. three (3) counting exercises (max. six (6) scores for Vault) will be averaged and the gymnast with the highest average prevails.
- d. If the tie remains, the total D-scores of the max. three (3) counting exercises (max. six (6) scores for Vault) will be averaged and the gymnast with the highest average prevails.

A special award ceremony must be held at the last World Challenge Cup Competition of the year in which the World Challenge Cup series winners shall receive a Cup.
